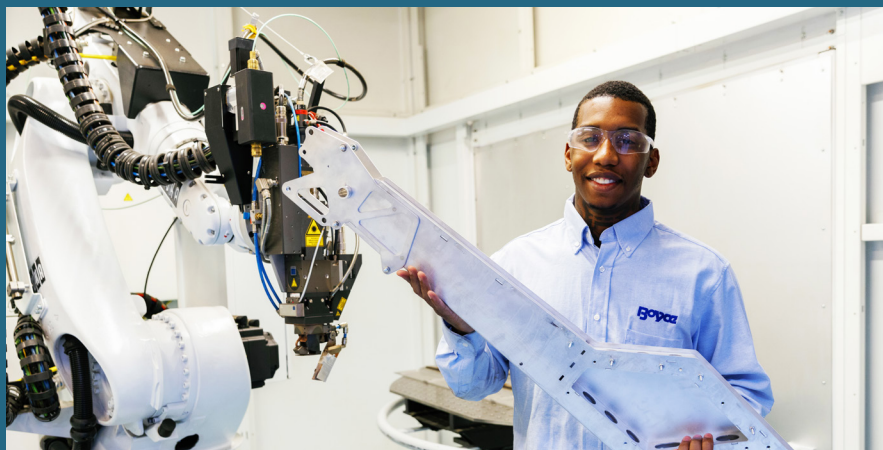

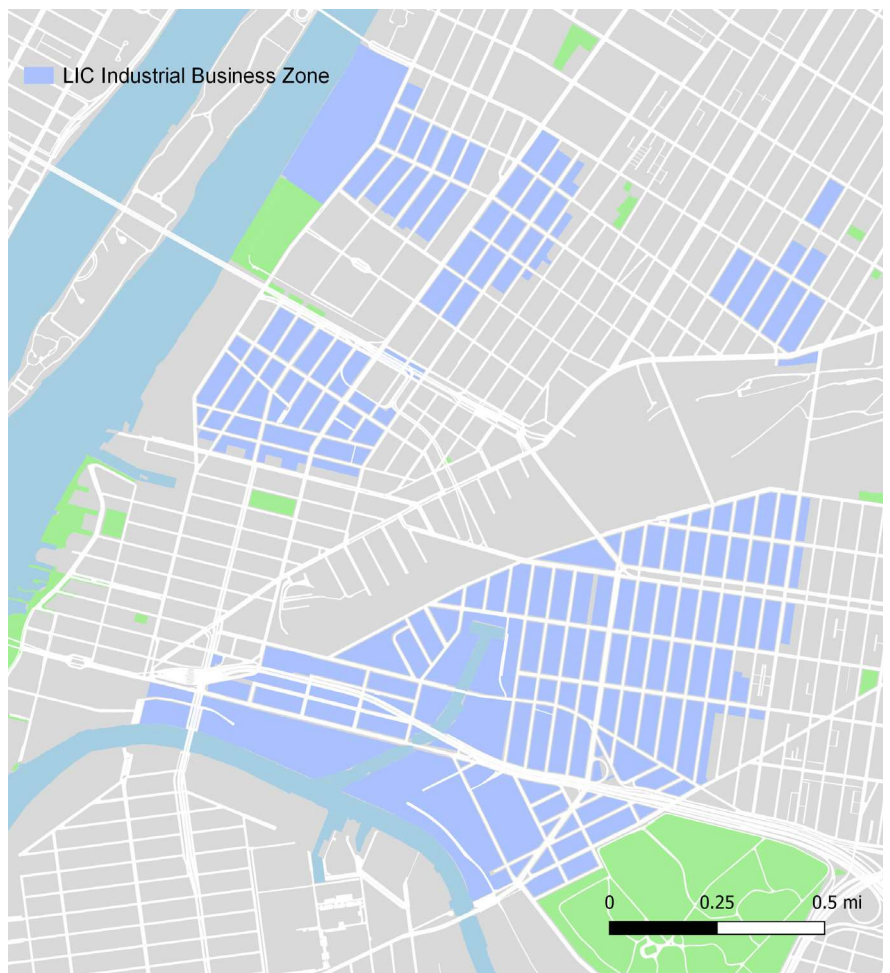

We Know LIC Business

Since our founding in 1979, we have provided one-on-one assistance to businesses in the greater LIC area on a wide variety of issues, including: financing and incentives, real estate, operational issues, energy savings, and staff training.

We also manage the LIC Industrial Business Zone (IBZ), established in 2006 by New York City, to protect existing manufacturing districts and encourage industrial growth citywide. Our IBZ working group, composed of IBZ-area businesses and stakeholders, works to address and improve the operational challenges of the IBZ area south and east of the Sunnyside Yard.





Financing & Incentives

Financing

504 Loan **SBA**



Financing acquisition of major fixed assets, such as equipment or real estate.

7(a) Loan **SBA**



Participating lenders provide loans of up to \$5 million that are partially guaranteed by SBA to small businesses. Businesses apply directly to the lender for financing.

Community Advantage Loan



SBA

Participating lenders offer loans of up to \$250,000 to small businesses and entrepreneurs to help drive economic growth and job creation.

Contractor Financing Fund



SBS

Low-cost loans for eligible businesses applying to be or are currently engaged as prime contractors or subcontractors under a contract with a City agency, NYCEDC, or any other City-funded entity.

Conventional Financing



PRIVATE BANKS & CDFI

Local banks offer conventional private financing products with no government guarantee, such as Mortgages, Term Loans, Lines of Credit, etc., for different sizes and types of projects.

Incentives

Relocation and Employment Assistance Program (REAP) DOF

REAP provides tax credit of up to \$3,000 per employee per year for businesses relocating to eligible areas. Improvements to relocation premises are required.

Commercial Expansion Program (CEP) DOF

CEP provides rent abatement of up to \$2.50 per square foot on new, renewal, and expansion leases in eligible areas. The program has a term of up to five years for commercial businesses and ten years for industrial businesses. Improvements to premises are required.

Commercial and Industrial Energy Efficiency Program

CON EDISON

Con Edison offers an array of options to businesses such as financial incentives to upgrade to energy efficient equipment to help lower utility bills. Customers can also get paid to temporarily reduce their energy usage in the summer with their smart usage rewards program.

Build & Train Teams SBS

- (1) A competitive grant program that provides up to \$400,000 to help businesses invest in training employees. Businesses choose training courses that will impact their bottom line and the program covers up to 70% of the costs.
- (2) On-the-Job Training is a discretionary grant to help qualified businesses with on-boarding and training new employees. Funds cover up to 70% (limited to the first 280 hours) of the eligible trainee's wages during training.

Energy Cost Savings Program (ECSP) SBS

ECSP reduces the delivery component of utility bills by up to 45 percent for electricity and 35 percent for natural gas. Businesses must (1) relocate to; (2) make improvements to property in; or (3) lease space in previously improved buildings in qualified areas.

Industrial and Commercial Abatement Program (ICAP) DOF

Property tax abatement to commercial and industrial buildings, for up to 25 years. Properties must be improved by at least 30 percent of the assessed value. Industrial properties improved by at least 40 percent of the assessed value are eligible for additional abatements.

Excelsior Jobs ESD

Incentives to firms in targeted industries to create and maintain jobs and make significant financial investment.

Federal and State R&D Credit

The federal and NYS government offer tax credits to encourage R&D activities, and they are not just for companies with white-coat research labs.

Global NY ESD

Provides grants and financing programs to help NYS companies start selling overseas or expand their global export.

Industrial Business Zone (IBZ) Relocation Credit DOF

IBZ Credit provides industrial businesses relocating to designated IBZ areas with tax credit of \$1,000 per employee and up to \$100,000 in total.



About Us & What We Do

Long Island City Partnership (LICP) is the neighborhood development organization for LIC. Our mission is to advocate for economic development that benefits the area’s industrial, commercial, science and technology, cultural, tourism, and residential sectors. The goal is to attract new businesses to LIC, retain those already here, engage residents and visitors, and promote a vibrant and authentic mixed-use community. LICP also operates the LIC Business Improvement District and LIC Industrial Business Zone (LIC IBZ), providing business services and assistance.

In addition to Business Assistance, some of our other initiatives include:

Business Improvement District (BID)

Managed by the Long Island City Partnership, the LIC BID provides direct supplemental services including daily sanitation, maintenance of capital improvements, visitor attraction and safety programs, and promotion of the district through marketing, events, retail attraction, and development information.

Events

LICP hosts year-round events to connect and build a strong, close-knit community, educate and promote businesses, and support our partners. Examples of our events are the Real Estate Breakfast, LIC Springs, the LIC Summit, and Lunar New Year celebration.
